

TERMS AND CONDITIONS

SatLeo Labs Private Limited

These Terms and Conditions (“**Terms**”) govern access to and use of the website(s), the Platform and Services provided by **SatLeo Labs Private Limited**, a company incorporated under the laws of India (“**SatLeo**”, “**we**”, “**us**”, or “**our**”).

By accessing or using the Platform or Services, you (“**You**” or “**User**”) agree to be bound by these Terms and our Privacy Policy, which is incorporated herein by reference and shall be read together with these Terms. If you do not agree, please do not access or use the Platform or Services.

1. Scope and Applicability

These Terms apply to:

- (i) visitors to our Platform;
